History of Health-check (KENSHIN) in Japan



Health-check for employees have been compulsory Since 1947

- Industrial Safety and Health Law Article 66.
- Employers must have their employees undergo health-check by a doctor.
- Employees are obliged to undergo health-check conducted by their employers.
- Penalties such as fines for non-compliance with the above regulations



What tests are required on each part of the body?

• Health-check is performed for each part of the head, eyes, lungs, heart, gastrointestinal tract, etc. (X-ray examination, ultrasonography, blood test, etc.)

• ABCD evaluation should be done for the test results by judgment logic..

• Based on a medical point of view, the results report is communicated to the examinee in an easy-to-understand manner In order to prevent lifestyle-related diseases .

Health-checks in the lifecycle









Pediatric checkup

Checking the health condition of infants, including growth and development, nutritional status, presence or absence of diseases, including congenital diseases, and the timing and types of vaccinations.

Student checkup

Two big roles, one is to check the presence or absence of illness to understand the health condition, and the other is to clarify health issues in schools and use them for health education.

Regal medical checkup

It is stipulated by the "Industrial Safety and Health Act". Employers are obliged to conduct "regular health checkups" for all workers "at the time of hiring" and "once a year".

Lifestyle-related disease checkup

Focusing on metabolic syndrome (visceral fat type obesity), health guidance will reduce the prevalence of lifestyle-related diseases such as diabetes and the prevalence group.

Similarities between Vietnam and Japan



• Population scale

- Universal health insurance system
- Obligation to have employees undergo a healthcheck
- Increase in lifestyle-related diseases and cancer
- Issue of rising medical expenses






Why healthcare DX required?

Effect for Individual

- Identify health condition by ourselves correctly \downarrow
- Review exercise habits based on body fat percentage
- Assessment of the condition and review of lifestyle habits based on imaging tests
- The health-check report advises what needs to be improved
